

PREMIUM GRASS BLADES

LIMITED TEN YEAR WARRANTY

PREMIUM GRASS BLADES (“PGB”) MANUFACTURER’S WARRANTY IS AS FOLLOWS, AND EXTENDS ONLY TO THE ORIGINAL PURCHASER AND IS NON-TRANSFERABLE.

“PGB” WARRANTS THAT IF THE SYNTHETIC GRASS OVERLAY IT SUPPLIED PROVES TO BE DEFECTIVE IN MATERIALS OR WORKMANSHIP RESULTING IN PREMATURE DETERIORATION, DURING NORMAL USE OF THE PRODUCT, WITHIN TEN (10) YEARS FROM THE DATE OF PURCHASE, OR EXPERIENCES EXTENSIVE FADING, BREAKDOWN OR DEGRADATION DUE TO EXPOSURE TO NATURAL ULTRAVIOLET RAYS WITHIN THE SAME TEN (10) YEARS PERIOD, “PGB” WILL, AT ITS SOLE OPTION EITHER:

- 1) REPAIR OR REPLACE THE AFFECTED AREA WITHOUT CHARGE TO THE PURCHASER.
- 2) ISSUE A CREDIT EQUAL TO THE COST OF THE SYNTHETIC GRASS MATERIAL ONLY.

THE CREDIT SHALL BE ISSUED, AS A PERCENTAGE OF THE REPLACEMENT COST/ OR THE PURCHASE PRICE (WHICH IS EVER LESS) OF THE NEW SYNTHETIC GRASS OF THE SAME OR COMPARABLE QUALITY. THE CREDIT WILL BE GOOD ONLY TOWARD THE PURCHASE OF “PGB” SYNTHETIC GRASS. THERE WILL BE NO CASHPAYMENT.

- ALL CLAIMS MUST BE MADE WITHIN 90 DAYS OF THE ISSUE BECOMING EVIDENT.
- THIS WARRANTY DOES NOT COVER THE INSTALLATION OF THE SYNTHETIC GRASS OR ANY ISSUES STEMMING FROM THE INSTALLATION.
- PRORATED MATERIAL VALUE TO BE COVERED AT A RATE OF LESS ONE TENTH (1/10) PER ANNUM FROM DATE OF PURCHASE
- THIS WARRANTY DOES NOT COVER SURFACE DETERIORATION RESULTING FROM NORMAL ‘WEAR AND TEAR’ OR ANY DAMAGES CAUSED BY LOCATION CONDITIONS OR SUN MAGNIFICATION MELTING FROM LOW E WINDOWS, AND IMPROPER INSTALLATION BEYOND ITS CONTROL, ACCIDENTS, MISUSE, ABUSE, NEGLIGENCE, EXPOSURE OF THE PRODUCT TO INAPPROPRIATE FOOTWEAR (I.E. METAL CLEATS), TOBACCO PRODUCTS, CHEMICALS OR CLEANING AGENTS, FIRE, FLOODS, VANDALISM, ACTS OF GOD.
- THIS WARRANTY DOES NOT COVER ANY DAMAGE RESULTING FROM ATTEMPTED REPAIR BY ANYONE OTHER THAN “PGB” OR IS AUTHORIZED AGENTS.
- “PGB” HEARBY DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND DISCLAIMS LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
- “PGB” SPECIFICALLY EXCLUDES AND WILL NOT PAY CONSEQUENTIAL OR INCIDENTAL DAMAGES UNDER THIS WARRANTY. THIS INCLUDES ANY DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE USE OR PERFORMANCE OF THE SYNTHETIC GRASS, INCLUDING, BUT NOT LIMITED TO DAMAGES FOR ECONOMIC LOSS, EXPENSE, PERSONAL INJURY ETC.
